### New Executive Director for AQA

Emeritus Professor Pat Walsh, Chair of the Board of AQA, said that Professor Matear brings a wealth of academic quality and management experience to the role and will continue on the good work undertaken by Dr Cameron and her predecessors.

## Cycle 5 Academic Audits

The AUT University audit panel was chaired by Emeritus Professor Dugald Scott. Professor Scott was joined by Professor Eric Pawson (University of Canterbury), Associate Professor Hon. Luamanuvao Winnie Laban (Victoria University of Wellington), Dr Fatuaiga Lorraine Petelo (Lincoln University) and Professor Elizabeth Deane (Australia).

The Board of AQA has, among its terms of reference, responsibility for appointing audit panels and for receiving and approving the release of audit reports. The Board must ensure that the process of audit is such to produce reports that reflect an independent judgement, are evidence-based and that are perceived as authoritative, rigorous, fair and perceptive. # 2016 APQN Conference and AGM and INQAAHE Forum

Registrations for the 2016 APQN Conference and AGM are now open. Hosted by Fiji Higher Education Commission (FHEC), the APQN Conference and AGM will be held in Natadola, Fiji on 26-27 May 2016 with a theme of "Sustainable Development of Quality Assurance in Higher Education". The APQN event will be preceded by the INQAAHE forum from 22-24 May at the same venue. According to Dr Jagannath Patil, President of APQN and INQAAHE. "the culmination of both events will add convenience to about 100 members from the Asia-Pacific region who are active in both networks." The APQN conference will be open to all registered delegates within and beyond the Asia-Pacific region. Registrations completed before 31 December 2015 will attract an early discount rate. The deadline for the submission of contributions is 10 February 2016.

### Giving Effect to Audit

Martin Boswell, Senior Academic Quality Advisor at Victoria University of Wellington, has recently had an article published in the Journal of Higher Education Policy and Management (2015, Vol. 37, No. 5, 572–585). "Giving effect to quality audit recommendations: a case study from an organisational culture perspective" explores how Victoria University responded to auditors' recommendations following its 1996, 2001, 2005 and 2009 academic audits. The article flows out of Martin's recently completed capstone project for his Master of Tertiary Education Management, conferred by the University of Melbourne. The article takes a detailed look at the University's progress in the adoption of audit recommendations over time and arrives at a number of implications for the University, for auditors and for AQA. Martin concludes that "there are numerous forces working on universities. Audit alone cannot change institutions, and not quickly" but nevertheless suggests that the model used in his research "may be applicable to other institutions wishing to review their own quality assurance progress over time". # New UK Higher Ed Green Paper

The Department for Business, Innovation and Skills in the UK has released a green paper for discussion entitled "Fulfilling Our Potential: Teaching Excellence, Social Mobility and Student Choice". The document includes a number of proposals which it says will "reshape the higher education landscape to have students at its heart. Its core aims are to raise teaching standards, provide greater focus on graduate employability, widen participation in higher education, and open up the sector to new high-quality entrants." Key points from the paper being considered by the UK government:

- There would become a single regulator of universities called the Office for Students (OfS).
- New providers would be given quicker access to student funding and there would be no cap on student numbers.
- Success at higher levels of the proposed Teaching
  Excellence Framework (TEF) would allow universities to
  increase tuition fees in line with a series of fee caps. The
  power to set fee caps would lie with the secretary of state for
