

## **Quality Enhancement**

#### QA of Cross-Border Education

The European Association for Quality Assurance in Higher Education has been granted funding for a project entitled "Quality Assurance of Cross-border Higher Education (CBHE)". Between 1 October 2013 and 31 December 2015, the project is exploring the different ways in which European QA agencies and higher education institutions (HEIs) address the accreditation and quality assurance of programmes delivered outside of their countries. The outputs of the project will include a toolkit on quality assurance of CBHE for agencies and HEIs, common principles for quality assurance of CBHE for agencies and HEIs, and publication of the project outcomes and recommendations in a comprehensive final report. https://gache.wordpress.com/

# Ako Aotearoa Announce newly-awarded National Project Fund projects

Ako Aotearoa has announced the successful project teams to receive funding through the 2014/2015 round of the Ako Aotearoa National Project Fund (NPF). Three new major projects have been funded:

- "Building an evidence-base for teaching and learning design using learning analytics data" co-led by Associate Professor Cathy Gunn (The University of Auckland) and Dr Jenny McDonald (University of Otago)
- "He Tātua o Kahukura" led by Associate
   Professor Leonie Pihama (Te Kotahi Research Institute, The University of Waikato)
- "Making the invisible visible: Illuminating undergraduate learning outcomes beyond content and skills" led by Dr Barbara Kensington-Miller (The University of Auckland).

## **AQA 2015 External Review**

Like New Zealand universities,
AQA is itself subject to regular
external review. The last review of
AQA (then the NZUAAU) was held
in 2009. The 2015 external review
of AQA is now underway with a
site visit by a panel of three
members in June. The review is
being managed by Universities
New Zealand.

The overall objective of the review is to assess how effectively AQA:

 assists the Vice-Chancellors' Committee to discharge its responsibilities for quality assurance under the Education Act:

- meets its own mission and objectives;
- meets the INQAAHE Guidelines of Good Practice;
- transacts its core business processes.

The review is being framed under five headings: accountability, transparency and resources; relationships between AQA and the universities; external review; quality enhancement; and external activities.

#### **AQA Board's Role in Audit**

The Board of AQA has, among its terms of reference, responsibility for appointing audit panels and for receiving and approving the release of audit reports. The Board must ensure that the process of audit is such to produce reports that reflect an independent judgement, are evidence-based and that are perceived as authoritative, rigorous, fair and perceptive.

The Board receives and reviews the formal follow-up report from each audited New Zealand university approximately 12 months after the public release of the audit report.



#### **International Focus**

One of the objectives of the AQA is to improve the quality of AQA activities, including audit practice, by interaction with other education and academic quality assurance agencies, both nationally and internationally. AQA is a member of the Asia-Pacific Quality Network (APQN) and the International Network for Quality Assurance Agencies in Higher Education (INQAAHE).

#### **APQN News**

In January 2015, the QACHE (Quality Assurance of Cross-border Higher Education) project held a small-scale regional forum in Macau with invited APQN members. The QACHE project is looking into different ways in which European QA agencies and institutions address the accreditation and quality assurance of programmes delivered outside of their countries.

# What's happening in external QA internationally?

#### Australia

In February, TEQSA (the Tertiary Education Quality and Standards Agency) released a document entitled "A risk and standards based approach to quality assurance in Australia's diverse higher education sector". This document sets out TEQSA's approach to quality assurance.

#### **United Kingdom**

Also in February, HEFCE (the Higher Education Funding Council for England) released two comparator studies to inform the current quality assessment review in England, Wales and Northern Ireland. One of these studies provides a useful comparative account of approaches to the assessment of academic standards and quality in Norway, the United States and Australia, focusing on issues such as the role of audit and reporting, the burden of different approaches, and the role of outcomes-based approaches.

According to the QAA, "Critics, including many students, academics and professionals in the field, claim that Economics teaching has become too narrow and conceals rather than reveals underpinning ideologies." - NZQA is seeking feedback on its work to reference the New Zealand Qualifications Framework (NZQF) and the Australian Qualifications
   Framework (AQF). NZQA and the Australian Government Department of Education and Training have drafted a referencing report which sets out the comparability of the levels and qualification types of the two national qualification frameworks.
