Academic Audit

AQA is currently in a 'roll-over' phase between completing activities and reviews from Cycle 5 and getting underway with Cycle 6.

In Cycle 5, the AQA Board accepted the one-year follow-up report for AUT at its July meeting and the remaining follow-up visits for the University of Otago and Lincoln University have been scheduled. AQA is also developing a series of review and analysis reports from Cycle 5. Three reports are anticipated – a review of Cycle 5 processes, a thematic analysis of Cycle 5 reports, particularly commendations, affirmations and recommendations and an impact assessment which will be based on follow-up reports. The first two reports are scheduled to be completed by the end of the year and the third early in 2018.

In terms of Cycle 6, the Quality Managers met in Wellington on 21 August to discuss the 'refresh' of the Cycle 5 Audit Framework for use in Cycle 6 and develop a first draft of a Cycle 6 Audit Framework. The focus at this point has been on ensuring the coverage of the framework is appropriate and further work will refine the wording and expectations around provision of evidence.

Another component of Cycle 6 which is underway is the development of students, or recent graduates, as members of audit panels. A Student Voice in Universities Summit, to be held jointly with NZUSA the day before Support for Quality, will contribute to this.

Cycle 6 Enhancement Theme

The topic for the Cycle 6 Enhancement Theme has been finalised as “Access, Outcomes and Opportunities for Māori learners and for Pasifika learners”. It is expected that findings from theme activities will be relevant to other groups of learners who are under-represented in universities.

The first meeting of the Enhancement Theme Steering Group considered the topic of the theme, terms of reference for the group and a provisional operationalisation timeline. One of the questions discussed at the meeting is how the universities will ‘learn’ from the enhancement theme. Two sorts of reports are envisaged to address this. The first will be ‘synthesis’ reports which will attempt to collate progress and share good practice from across theme initiatives and activities. The second will be ‘evaluative’ reports which will assess the benefits gained from working in a collective way on the enhancement theme. It is anticipated that next year’s Support for Quality conference will focus on sharing progress so far across the theme.

The Higher Education Pacific Peer Quality Network

The Higher Education Pacific Peer Quality project involves five universities and higher education institutions in New Zealand and the Pacific benchmarking with one another on topics including teaching quality, programme quality and student voice. The emerging network is holding a peer review workshop for the project teams on 6 November and a collaboration forum with invited guests to share what they have learnt and their mutual experiences on 7 November.

Student Voice

This week we begin our process to develop a refreshable pool of high-level student representatives who will eventually constitute the group able to be drawn upon as academic auditors. The Student Voice at Universities Summit on Wednesday brings student representatives who have been or will be involved in quality enhancement mechanisms at their institutions together for knowledge transfer and professional development.

Students from around the country will assemble at Universities New Zealand where those who have already been in office will share the things that they would have liked to have known before they started, and those coming into office will seek advice as to how to implement their initiatives. University Quality Managers will run sessions identifying the skills and support that student representatives involved in panel reviews and course approvals.

The nature of student representation means that students will turn over. Instead of pretending that does not happen, this initiative looks to make sure that there are good succession plans in place and that incoming representatives can be useful straight away. It is an important step towards the joint workplan for the New Zealand Union of Students' Associations and the Academic Quality Agency for New Zealand Universities.

The Summit will also be joined by Sophie Johnson, President of the Australian National Union of Students, here to observe and see if the initiative could be one that is mirrored across the Tasman.
