Cycle 5 Academic Audits

The site visit for the academic audit of the University of Waikato took place in August. It is anticipated that the report of this audit will be available from the AQA website in early-December 2015. The Waikato Audit Panel was chaired by Professor Sheelagh Matear (Lincoln University). Professor Matear was joined by Darryn Russell (University of Canterbury), Professor Vernon Squire (University of Otago), Emeritus Professor Deborah Willis (recently retired from Victoria University of Wellington) and Emeritus Professor Bob Elliott (Australia).

The academic audit of AUT University is well underway and the site visit for this audit is scheduled for 17-19 November 2015. In 2016, AQA will be undertaking academic audits of the University of Otago (site visit May 2016) and Lincoln University (site visit August 2016). www.aqa.ac.nz/cycle5

Quality Enhancement

HEA Professional Standards Framework

The Higher Education Academy (HEA) is a UK-based organisation responsible for enhancing teaching and supporting learning in higher education. HEA has developed and, since 2006, supported a Professional Standards Framework which is a nationally-recognised framework for benchmarking higher education teaching and learning support. Part of the Framework, the HEA Fellowship Programme, provides a recognised badge of "professional competency". According to the HEA, many educational institutions around the world are now starting to use the Fellowship Programme as a condition of appointment and promotion. The HEA has a current project with Massey University. Massey is exploring aligning their practices with the Professional Standards Framework (PSF). As part of the project, HEA will review Fellowship applications from Massey staff and "provide formative feedback in order to enable participants to construct a successful application for fellowship". 2015 Higher Education Compliance and **Quality Forum**

The report will be available from the AQA website within the next few weeks. AQA Board's Role in Audit

The Board of AQA has, among its terms of reference, responsibility for appointing audit panels and for receiving and approving the release of audit reports. The Board must ensure that the process of audit is such to produce reports that reflect an independent judgement, are evidence-based and that are perceived as authoritative, rigorous, fair and perceptive. The Board also receives and reviews the formal follow-up report from each audited New Zealand university approximately 12 months after the public release of the audit report. www.aqa.ac.nz/about-us/board

International Focus

One of the objectives of the AQA is to improve the quality of AQA activities, including audit practice, by interaction with other education and academic quality assurance agencies, both nationally and internationally. AQA is a member of the Asia-Pacific Quality Network (APQN) and the International Network for Quality Assurance Agencies in Higher Education (INQAAHE).

INQAAHE

INQAAHE is calling for research proposals from full or associate members. INQAAHE will fund three proposals up to USD\$2,500 to support the preparation of research papers or essays relevant to a range of topics including: new modes for quality assurance in well-developed systems; independence of quality assurance decisions; diversity of approaches to institutional and academic programme quality assurance including new modes of study (e.g. e-learning, MOOCs).

APQN

The first formal review for APQN's Asia Pacific Quality Register (APQR), was conducted of the Fiji Higher Education Commission in late-June 2015. As with the European Quality Assurance Register for Higher Education, APQN believes that the APQR will help facilitate mutual recognition and cross-border cooperation of quality assurance agencies in the Asia Pacific region.

Learning and Teaching in Europe

A recent report released by the European Universities Association (EUA) entitled "Trends 2015: Learning and Teaching in European Universities" explores the impact of major reforms across Europe over the past 15 years. From the authors: "The Bologna Process has emphasised several policy objectives in the past fifteen years and the longitudinal Trends data shows that quality assurance has been a



particularly important change driver during this period. Moreover, the development of internal quality assurance processes has been particularly remarkable. External quality assurance is changing to take into account these developments. It is shifting toward institutional audits and evaluations that are mission-driven and enhancement-led at the same time as quality assurance agencies emphasise the involvement of students and a dialogue with all stakeholders." www.eua.be/Libraries/publications-homepage-list/EUA_Trends_2015_web

New CEO for TEQSA

Anthony McClaran, the current Chief Executive of the QAA (UK), has been appointed the new Chief Executive Officer of the Tertiary Education Quality and Standards Agency (TEQSA) in Australia. BAC launches overseas HE accreditation

The British Accreditation Council (BAC) has introduced a new accreditation scheme for UK and overseas higher education institutions. BAC currently accredits 260 institutions in 12 different countries. The Independent Higher Education Scheme is available to any university in the UK and overseas which wishes to gain BAC accreditation. The Scheme complies with European Association for Quality Assurance in Higher Education guidelines. According to the CEO of BAC, the Scheme "provides reassurance for British universities in partnering with overseas institutions". The new Scheme incorporates the student learning experience as an explicit element of the accreditation and inspection process.
