## Cycle 6 Academic Audit

The first audit report in Cycle 6 was released in November 2022. The Panel for the academic audit of Waipapa Taumata Rau, University of Auckland made twelve commendations, ten affirmations and fourteen recommendations. The pattern of commendations, affirmations and recommendations reflects the strategic work underway at the University, including a substantial Curriculum Framework Transformation Programme (CFTP) and associated refresh of the University's Graduate Profile to align with the University's new vision and strategic plan. The report and a 'plain english' summary of findings are available on the AQA website.

The audit report for Te Herenga Waka | Victoria University of Wellington will be released next year.

AQA will seek feedback from universities and panel members on their experiences with the audit phase of Cycle 6. Feedback from the first two universities in the cycle will contribute to an initial review of the cycle. This will be completed in the first quarter of next year.

Three universities are scheduled to be audited in 2023. The site visit for Massey University | Te Kunenga Ki Pūrehuroa is scheduled for the week of 6 March 2023. The first planning meeting for the University of Canterbury was held on 12 December, with the University due to submit its self-review portfolio the week commencing 20th March 2023. Engagement with the University of Waikato has also commenced, with that University due to submit its self-review portfolio the week of 15 May 2023.

### Auditor Training

A second round of auditor training was held in October and a third round will be scheduled for February 2023. Any auditors who have completed modules 1 (An introduction to Te Tiriti o Waitangi) and 2 (Cycle 6 academic audit) and would like to participate in module 3 (Te Tiriti o Waitangi and academic audit) on Tuesday 7 February 2023 should contact Sheelagh. A module 2 session will also be held towards the end of February and will be advertised to members of the Cycle 6 Register of Auditors and Reviewers.

### Self-Review Preparation Workshops

AQA ran some self-review preparation workshops prior to the COVID-19 pandemic starting to impact on university activities and the Cycle 6 timeline. An online course on preparing for self-review is also available. A further workshop will be held in Dunedin on Thursday 9 February 2023. Please contact Sheelagh for further information.

# **Quality Enhancement**

It has been good to be able to return to faceto-face meetings for first the Student Voice Summit in November and then a Quality Forum in December 2022.

The Student Voice Summit helps prepare incoming members of students' associations executives for their roles in the year ahead. It covers the policy context for the sector and the roles of various agencies. A key feature of the Summit is students learning from students. Thanks to Massey University Te Kunenga Ki Pūrehuroa for their support of the Summit.

Quality managers from across NZ universities were able to meet for the first in-person Quality Forum since 2019. The Forum discussed a range of quality matters including the Code of Practice and its intersection with the Cycle 6 academic audit framework, experiences of the audit phase of Cycle 6 to date, and academic integrity and the growing threats (and some possible opportunities) from artificial intelligence. The Group heard from the Universities New Zealand (UNZ) Portfolio Manager for Academic Programmes who provided an update on CUAP, the

Programme Director for Evidence and Evaluation, also from UNZ, about the development of sector-level data dashboards and the Director Planning and Management Information from Te Herenga Waka about developments within the Tertiary sector, including funding.

Over the course of the day, the Forum also discussed the changing quality landscape including how the three quality bodies for the university sector needed to ensure their expectations were aligned so as not to duplicate requirements for universities. This could be a good topic for future discussion of quality assurance, along with what a Tiriti o Waitangi led approach to quality assurance would look like and the role of data.

## AQA Annual Report

The 2021-2022 AQA Annual Report is now on the AQA **website**. It contains a report from the Chair of the Board on his first year as Chair and the AQA financial statements and statement of performance. This year, AQA was audited as part of the financial audit of the New Zealand Vice-Chancellors' Committee and a note on the financial statements reflects this. This change in practice is part of achieving administrative efficiencies following the 2020 external review of AQA.

### **Objectives**

- to advocate for the needs, interests, and aspirations of ākonga Māori to thrive in education as their authentic Māori selves
- to support local Māori student associations and their leadership
- to hold institutions accountable in giving meaningful effect to Te Tiriti o Waitangi
- to assist student support services and ensure such services are relevant to ākonga Māori needs
- to enhance the experiences of ākonga Māori in tertiary education
- to maintain institutions' obligations to ākonga Māori in relation but not limited to, recruitment, retention, and completion
- to ensure ākonga Māori are valued members of an academic community that values te reo, tikanga, and mātauranga Māori as world-class knowledge systems
- to promote anti-racism and the decolonisation of the tertiary education system

The National Executive of Te Mana Ākonga is voted in by all Roopu at Te Huinga Tauira (Our Annual General Meeting). For 2023 myself and Ngawahine Thompson will be taking the lead. The duty of the National Executive involves advocating and supporting Tauira Māori on a local and national level. Te Mana Ākonga is currently made up of eleven **roopū**, from ten universities and one polytechnic, representing 30,000+ tauira Māori.

Highlights and achievements of this year's tari whakahaere include:

- successfully made constitutional amendments
- internal process mending and reviewing
- held 4 Hui kaiārahi across the country in collaboration with the national membership
- attended many governmental boards and hui to use student voice
- attended Kaapuia, a national Māori student Kapa Haka competition hosted by one of our membership
- held Te Huinga ki Tua alongside TKT for tumuaki across the motu. Voted in a new Tari Whakahaere successfully.

## Have You Seen This?

INQAAHE have launched a set of International Standards and Guidelines (ISG) to replace the Guidelines of Good Practice.
