# Cycle 6 Academic Audit

The audit phase of Cycle 6 is now well underway with the first university in the cycle - Waipapa Taumata Rau | The University of Auckland - due to submit its self-review portfolio next month, with Te Herenga Waka | Victoria University of Wellington following shortly after that. A summary of the audit schedule is in the AQA website.

## **Auditor Training**

Training for members of Cycle 6 audit panels is also getting underway. The ongoing COVID-19 pandemic has caused a rethink of how auditor training can take place and we are moving to a model of small group online workshops. This should also mean being able to provide more opportunities for auditor training which will be easier to access. Auditor training will consist of 3 modules:

Module 1: Introduction to Te Tiriti o Waitangi for non-Māori auditors who haven't previously

experienced Te Tiriti o Waitangi training (or equivalent). This is an Ako Aotearoa workshop. Māori auditors are welcome to take another Ako Aotearoa Te Tiriti workshop

designed for Māori.

Module 2: Cycle 6 Academic Audit – Framework, good practice and audit processes. Working with

and support student voices will be included in this module.

Module 3: Te Tiriti o Waitangi and Academic Audit. This is a new workshop developed and delivered

by Ako Aotearoa and will examine how Te Tiriti o Waitangi informs academic audit and how academic audit can contribute to upholding Te Tiriti o Waitangi. Māori auditors are

welcome to participate in the workshop, but it is not a requirement.

The first set of workshops will give first priority to members of the Register who have been appointed to or long-listed for appointment to audit panels. Further dates will be released soon.

# Work with AQA

AQA is continuing to seek a Deputy Director – Pou Ārahi Arotake to guide AQA's strategic goal of becoming a Te Tiriti o Waitangi responsive organisation and a good Te Tiriti partner. # **Student Voice**

Tēnā koutou. It is an immense pleasure to write this column in the AQA Newsletter at the start of my second year as National President of the New Zealand Union of Students' Associations. Building on the successes of 2021 is a huge focus of mine and progressing the transition to a learner-centric education system is a major part of this. One of my members charmingly described me as an elder statesman of the student movement and in my last year in the role genuinely embedding learner partnership in everything we and our providers do is the top priority.

Fatima Imran and Sam Blackmore join me in National Office this year as Co-Vice Presidents. Fatima was President of the Massey University Students' Association (MUSA) in 2021 and Sam is a stalwart of the student movement with roles as Lincoln University Students' Association (LUSA) President and NZUSA Mental Health Project Lead. Ellen Dixon has returned as our International Engagement and Research Officer and will be leading much of the mahi on our Income and Expenditure Report.

Last year's Waikato Students' Union President Kyla Campbell-Kamariera (Te Rarawa, Te Aupōuri, Taranaki Tūturu) is the 2022 Te Mana Ākonga Tumuaki. TMĀ have a real focus on growing the voice of Māori tauira and rebuilding Māori student activism post-Covid.

Alice Mander returns as Co-President of the National Disabled Students' Association alongside Lauren Dewhirst, a University of Otago graduate and former Otago Disabled Students' Association President. NDSA in its second year is committed to building strategic partnerships across the sector to grow the voices of learners who have gone unheard for decades.

Vikram Selvaraj, a student at UC is the new President of the New Zealand International Students' Association and has a real interest in working with providers to grow the voice of international learners in their education and make sure that they are genuinely involved in embedding the Code of Pastoral Care

Tauira Pasifika will be holding their AGM soon to elect their new leadership soon and with that we will have our full roster of national student leaders for 2022.

Uniting us in all our mahi is Whiria Ngā Rau | Progressing from student voice to partnerships which we launched at the end of 2021. Whiria Ngā Rau is envisaged as a gift from students to the tertiary sector and contains what we believe to the essential ideas underpinning genuine partnership with learners. The four rau that support Whiria; Whakapakari, Whakawhanaungatanga, Akoranga and Mahitahi for us get

to the core of what a learner-centric education system means. While the middle of an Omicron outbreak may seem like an odd time to be talking about partnership, Covid demonstrated two things. Firstly, we now know that can do things differently. Secondly, across the sector, where providers have working meaningfully with students, better outcomes have followed. What better time to work with learners than when hearing their voices could be the difference between them dropping out or completing their degree?
