AQA Marks 25 Years

AQA marked 25 years since being established in 1993 as the New Zealand Universities Academic Audit Unit at a small function in Wellington on 13th November 2018. Former Chairs Professors Emeriti Les Holborow and David Mackay and past members of the AQA Board were able to attend, along with former Director Dr Jan Cameron, the current AQA Board and staff, former and current auditors and members of universities and other parts of the tertiary education sector with an interest in academic quality. Others unable to attend sent notes which were displayed at the function.

In his speech the current Chair of the AQA Board, Emeritus Professor Pat Walsh, noted both the amount of consistency and continual change and evolution which characterised AQA's first 25 years. The current Executive Director Sheelagh Matear outlined how the current cycle built on that history and continued AQA's commitment to add value for New Zealand universities and their students.

Quality Enhancement



The last quarter of 2018 saw a lot of quality enhancement activity with a Quality Forum meeting on 3rd October, followed by a Student Voice Summit on 4th October and the first Enhancement Theme Symposium at the end of October.

The Quality Forum examined current and emerging topics in quality assurance through a series of sessions led by quality managers.

The topics were academic integrity, assessment, graduate profiles and graduate outcomes, contract and sessional teaching and facilitating and supporting organisational change. A summary of the day is available at: https://www.aqa.ac.nz/sites/all/files/AQA_Quality_Forum_2018_Summary_Report.pdf

The objectives of the Student Voice Summit were professional development and knowledge transfer for incoming student administrations by:

- learning from outgoing administrations, sharing good practices, ideas and updates on current issues,
- gaining an overview of academic quality processes and academic decision making in the university sector, and
- making connections among incoming administrations and between incoming administrations and quality

The first Enhancement Theme Symposium for New Zealand Universities was held in Wellington on 31 October 2018. It brought together members of university senior leadership teams, academics, professional staff who support Māori students and development, professional staff who support Pasifika students and development, quality managers and students to share and critique initiatives.

The objectives for the day were to share approaches and initiatives underway with respect to the enhancement theme, and to critique those approaches and explore what would be the implications of them operating at scale (either whole of university or nationally).

The day was structured according to the three areas of emphasis (topics) identified across the universities' enhancement theme plans:

- Access,
- Student success, and
- Organisational change;

plus, a final session that considered a provisional synopsis of the day.

Mid-Cycle Reports

The AQA Board has reviewed and accepted mid-cycle reports from Massey University, The University of Auckland and Victoria University of Wellington. Each of the three topics was introduced with a plenary presentation or panel and followed by a workshop. Workshops were facilitated and each included a rapporteur who produced a summary of the workshop's discussion of key questions:

- What key initiatives are underway?
- What is needed to improve?
- What are the barriers to greater collaboration on this topic?
- What implications might initiatives have at greater scale, would they make a system-level improvement?
- If funding wasn't a constraint, what would you do?
- What is highest priority action to achieve significant progress?

A provisional synopsis of the workshop sessions was presented by the Chair of the Enhancement Theme Steering Group. A final panel session and series of workshops were then asked to respond to this Provisional Synopsis in terms of:

- From your perspective, what are the strengths in this summary?
- Where are the gaps?
- What would the priorities be?

- Establishing the National Pasifika Liaison Officer role at NZUSA, supporting the work on the Cycle 6 Enhancement Theme, and
- Enabling student auditors to sit on academic audit panels for Cycle 6.

The outcomes of these achievements have been felt across the country. Education student representatives are now more connected, more empowered and more equipped to carry out their responsibilities compared to when I first started as an Academic Vice President in 2015.

A highlight for student voice this year was having Te Mana Ākonga, the National Māori Student Association, co-host our Student Voice at Universities Summit, allowing for a stronger partnership between our organisations.

I would like to thank the numerous university staff and students I have engaged with over the last four years as a student representative. From the wonderful people at my home university who helped me to learn the ropes as I began my journey, to the fantastic Sheelagh Matear for championing our student voice kaupapa, thank you for helping to create a culture of student partnership across New Zealand's universities.

It's been a wonderful four years. I look forward to seeing even more progress as we move from 'student voice' to 'student partnership' over the next four years, and beyond.
